#### What is Tribal Consultation?

- The Department of Justice's annual Tribal Consultation on Violence Against American Indian and Alaska Native Women is held pursuant to Public Law 109-162, Title IX, Section 903, Violence Against Women Reauthorization Act of 2005
- Section 903 requires the Attorney General to conduct an annual consultation with Indian tribal governments to address the federal administration of all tribal funds and programs established under VAWA

## **Purpose of Tribal Consultation**

- Section 903, VAWA 2005 directs the Attorney General to solicit recommendations from Indian tribes on the following:
  - Administering tribal funds and programs;
  - Enhancing the safety of Indian women from domestic violence, dating violence, sexual assault, stalking, & sex trafficking;
  - Strengthening the federal response to the above violent crimes

## **Annual Consultation Report**

- Section 903, VAWA 2005 mandates the Attorney General to submit a report to Congress on the annual tribal consultation that
  - contains recommendations of Indian tribes made during the year covered by the report;
  - describes actions taken during the reporting year to respond to recommendations made during the year or a previous year; and
  - describes how the Attorney General will coordinate and collaborate with Indian tribes, Secretary of HHS, and Secretary of the Interior to address recommendations made

### **Notice of Annual Consultation**

• Section 903, VAWA 2013 requires the Attorney General *not later* than 120 days before the consultation date to notify tribal leaders of the date, time, and location of the tribal consultation.

## Significance of Consultation

Tribal consultations with federal entities provides....

- Avenue for tribal leaders to express what tribes want/need (and how) to keep Native women safe
- Opportunity for feedback on what is and isn't working as it relates to how funds are administered.
- Opportunity to receive feedback on program requirements
- Opportunity to bring awareness to current issues
- Opportunity to help design a legal framework for change on specific issues and removal of barriers, inequity, etc

## **Platforms for Change**

• National platform unites movement on a national level

• Regional platform unites movement on a regional or tribal-specific level

## **Preparing for Tribal Consultation**

- Review VAWA 2013 in context of respective tribe/region
- Identify tribal or region-specific platform issues
- Develop consultation statement on specific platform issues

## 2017 Priority Issues of Concern

- Ineffective public safety funding mechanisms
- Inadequate protections from sexual assault and services for women surviving rape
- Limited accountability for tribal protection and exclusion order violations by non-Indians
- Extractive industry impact on domestic and sexual assault crimes by non-Indian perpetrators
- Inadequate response to issues of missing and murdered Native women
- Failure of state governments to give Full Faith and Credit to tribal orders of protection
- Need for complete *Oliphant* fix to address sexual assault and other domestic violence appendage crimes

## 2017 Priority Issues of Concern

- OVW Rescission from Tribal Grant Programs
- Funding disparity for tribes VOCA, FVPSA
- Funding disparity for tribes in PL 280 jurisdictions
- Absence of SDVCJ jurisdiction Alaska, Maine
- Tribal Access Program requirements
- VAWA 904 National Baseline Study limitations-AK
